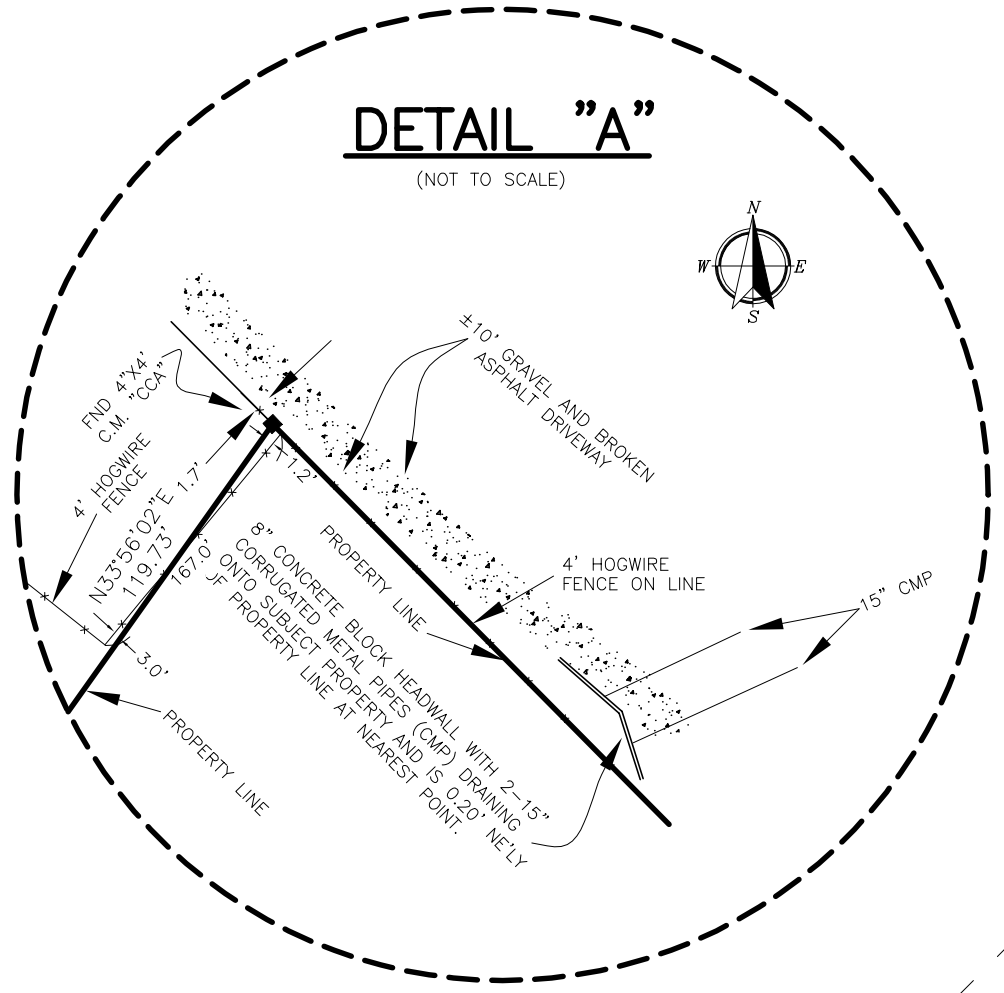


FLOOD CERTIFICATE:

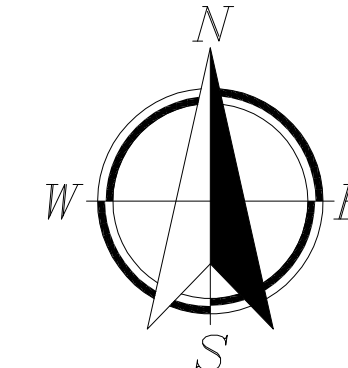
NOTES:

- 2) THIS SURVEY WAS PREPARED WITHOUT THE BENEFIT OF ANY FORMAL TITLE WORK.
- 3) THIS SURVEY DOES NOT ADDRESS ANY ENVIRONMENTALLY SENSITIVE ISSUES, IF ANY.
- 4) THE FIELD DATA UPON WHICH THIS MAP OR PLAT IS BASED ON IS GPS ONE POINT LOCALIZATION ON SITE AND COLLECTING CONTROL TRAVERSE POINTS FOR ALL LOCATIONS SHOWN HEREON. VARIOUS CHECKS WERE MADE BETWEEN SAID GPS CONTROL POINTS USING CONVENTIONAL SURVEY METHODOLOGY WITH A VALUE OF ERROR NOT EXCEEDING 1" IN 15,000' OF CLOSURE FROM GPS POINT TO GPS POINT. THIS MAP OR PLAT CALCULATED FOR CLOSURE AND IS FOUND TO BE ACCURATE WITHIN ONE FOOT IN 100,000+ FEET.

SURVEYOR'S NOTES

1) THE RECORDED METES AND BOUNDS DESCRIPTIONS FOR THE BOUNDARIES OF ALL PARCELS THAT COMPRISE THE PERIMETER BOUNDARY OF THE SUBJECT PROPERTY DESCRIBED AND SURVEYED HEREON CONTAIN GROSS GEOMETRIC ERRORS. IN THE PROCESS OF CALCULATING THE RECORDED DEED ACRES FOR SAID PARCELS, IT IS THE SURVEYOR'S OPINION THAT THE AREA OF EACH PARCEL WAS INTENDED TO BE CONVEYED BASED ON THE METES AND BOUNDS DESCRIPTION RATHER THAN THE ACRES STATED IN SAID DEED. ALTHOUGH IT IS THE SURVEYOR'S COMMON PRACTICE TO NOTE DIFFERENCES BETWEEN DEED BEARINGS AND DISTANCES AND FIELD ACQUIRED MEASUREMENTS, THIS SURVEY ONLY DEPICTS THE FIELD ACQUIRED MEASUREMENTS DUE TO AFOREMENTIONED ERRORS. DEED BEARING AND DISTANCES ARE NOT SHOWN HEREON. A COPY OF THE DEEDS IN QUESTION ARE ATTACHED TO THE SURVEYOR'S REPORT.



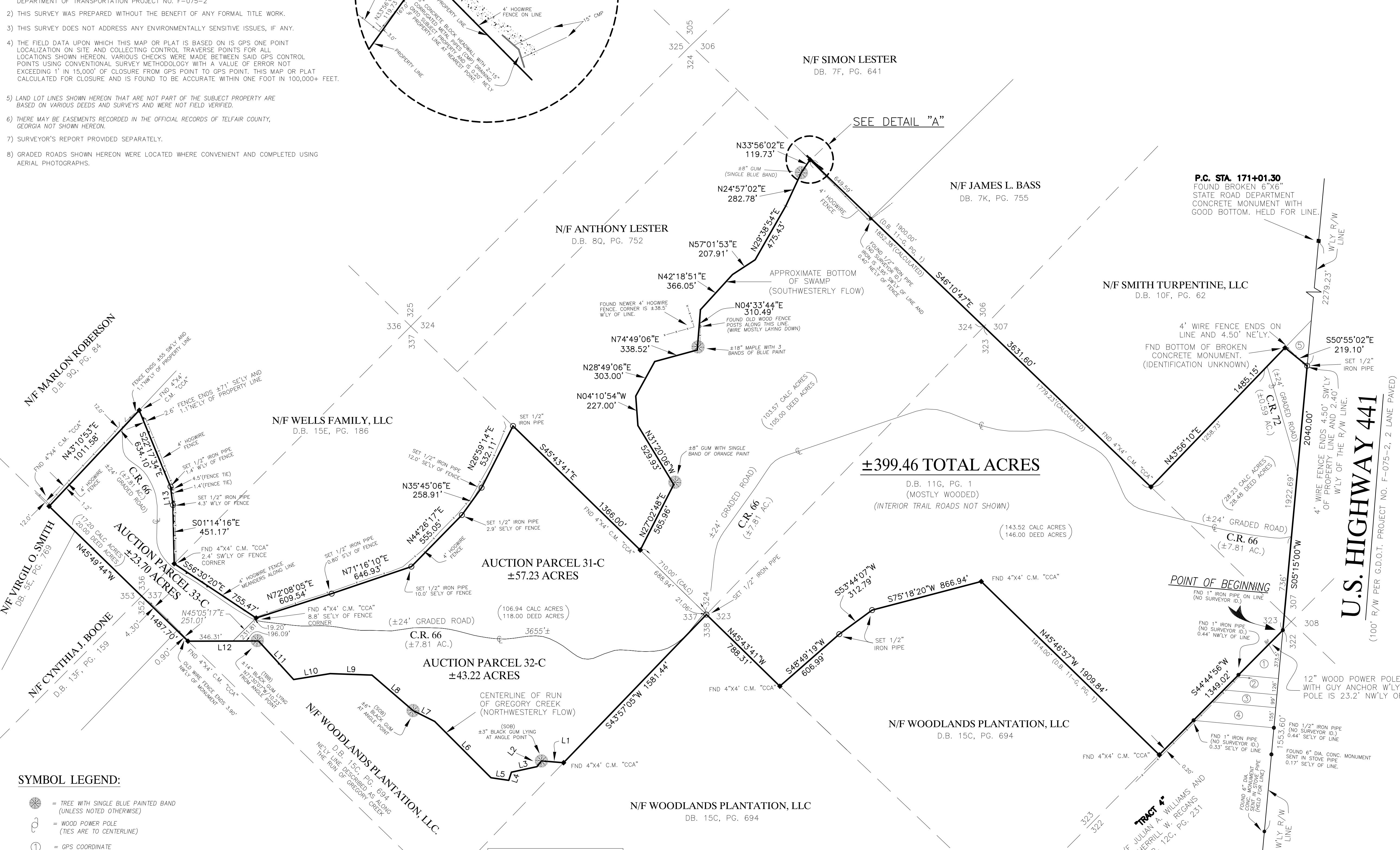
